You are responsible for informing Vermelion if your information changes.

2. Collection of your information by third parties

Owners or information system administrators of third-party websites that have links to the Vermelionwebsite, may collect personal information about you when you use these links. Vermelion (PTY) Ltd, does not control the collection or use of personal information by third parties and this privacy statement does not apply to third parties. Vermelion (PTY) Ltd, does not accept any responsibility or liability for third-party policies or your use of a third-party app, platform, or service.

Vermelion (PTY) Ltd, also uses certain social networking services such as Facebook, WhatsApp, Instagram,LinkedIn, and Twitter to communicate with the public and Vermelion (PTY) Ltd, clients. 8. Correction of your information

In accordance with POPIA, you have a right to correct any of your personal information held by Vermelion. This right should be exercised in accordance with the procedure outlined in the Vermelion (PTY) Ltd PAIA manual.

9. Objection to processing of your information

In accordance with POPIA, you may object to our processing of your personal information on reasonablegrounds relating to your particular situation, unless legislation provides for such processing.

11. Clickstream data

In the interests of better customer service, Vermelion (PTY) Ltd, may collect anonymous information from visitors to its websites. For example, Vermelion (PTY) Ltd, keeps track of the domains from which people visit its website and also measures visitor activity on its website.
